**RE: Forest Management Guide for Great Lakes-St. Lawrence Forest Landscapes
(EBR #010-5226)**

Dear Mr. Gluck,

Thank you for the opportunity to comment on the Environmental Bill of Rights Registry posting of the draft Forest Management Guide for Great Lakes-St. Lawrence Forest Landscapes (EBR #010-5226), and to remain apprised of proposed changes to forest management practices in Ontario.

Conservation Authorities play a significant role in forest management, with a mandate to protect, manage and restore Ontario's woodlands, wetlands and natural habitat, and have a long history of partnering with the Ministry of Natural Resources (MNR) to carry out this mandate. Conservation Ontario, on behalf of Ontario's 36 Conservation Authorities, commends MNR for undertaking this initiative to make the forest management planning process more efficient and promote the conservation of forest biodiversity.

Please consider the following comments when finalizing the draft Guide, which are based upon a review by Credit Valley Conservation staff.

In general, the standards, guidelines and best management practices found in the Guide are detailed and comprehensive. It is noted that the Guide addresses landscape, stand and site protection, and the protection of habitat and special features.

The Guide has several recommendations related to achieving appropriate forest structure and composition. However, equally strong recommendations are required related to maintaining forest (or other natural values) ecosystem function. For example, there are no

standards or guidelines related to connectivity. While connectivity is species-specific and problematic to prescribe in detail, general guidelines or best management practices should be given to highlight the importance of maintaining functional ecosystems. Recommendations regarding the maintenance of other ecosystem functions such as carbon balance and hydrology would further ensure that ecosystem functions are maintained in managed forested landscapes.

Once again, thank you for the opportunity to provide comments on the proposed Forest Management Guide for Great Lakes-St. Lawrence Forest Landscapes. We look forward to also reviewing the draft boreal forest landscapes guide when it is posted for public comment.
